

Robert M. Schmus - New Regional Director - Region 2

Robert Schmus was recently appointed the Regional Director for Region 2 of AFSA. Robert's career with IRS-CI spanned a period of 17 years, during which time he was a field agent for 11 years, a Centralized Case reviewer, SSA and DFO Analyst. He left CI for the US Postal Service, Office of the Inspector General as the ASAC in the Philadelphia Field Office. He states that at the time, this appeared to be a once in a lifetime opportunity as he was close to being eligible for retirement. He retired from the Postal Service in March, 2008 and has been an Asset Forfeiture Contractor with ATF since that time, a position he found through AFSA.

Robert says that he envisions the Regional Director keeping in touch with members in their respective area and possibly attempting to organize a local chapter of AFSA or at least getting members together for gatherings. He would also like to see former agents from his era getting more involved in the organization. That would include himself as he has not had the opportunity to attend an annual convention.

President's Message



On February 23, 2011 First Vice President Mary Frances Martin and I met with the Deputy Chief CI Rick Raven and his staff in Washington DC (the Chief was out of town that day). We wanted to continue a tradition of meeting with the IRS-CI headquarters staff to ensure a continuing and long-lasting relationship. I know we all recognize the importance of keeping the lines of communications open. This relationship has been instrumental in the past in helping AFSA-IRS members secure job opportunities, retired credentials, and

commemorative weapons to name a few things. Our presentation was well received with Rick and his staff being very complementary of AFSA as well as being genuinely pleased that we took the time to update them on AFSA-IRS.

We know that it will take all our efforts, from the AFSA Board to all its members, to ensure our continued growth. As of the end of March 2011, AFSA - IRS has over 1,200 paid members. We encourage each and every member to update his/her profile in the online directory to ensure all our mailings; announcements and newsletters can reach everyone without delay. In 2010 we converted to a website and lost some valid data during conversion. Which is why we encourage every member to take a few minutes to check your profiles and make sure it is current and correct. The approximate age grouping of the membership is as of February 13, 2011 was as follows:

The most striking change in demographics in just 4 years since our last report to CI Headquarters is the shift to a younger membership. As the number of members in their 50s and 60s going from 795 in 2007 to 991 today. A shift of 71% to 81% of total membership, as the membership has gravitated toward a younger base. This is a direct result of all the hard work of the district and regional representatives as well as the board at large.

There are approximately 156 active special agents in AFS-IRS as associate non-voting members. We know that there are many members who joined AFSA-IRS while they were active special agents. As they retire we hope they also take the time to update their membership profile to help us keep our records as current as possible.

Approximately 435 of the current members expressed interest in post retirement investigative employment as shown in their online profile. At least 500 are actively working as an employee or have their own business. I know that many of those currently working reach out to the AFSA membership for job opportunities, which is another reason to keep your profiles current.

I also want to remind everyone about our upcoming convention for 2011 that will be held in Asheville, North Carolina September 30-October 5, 2011 at the Grove Park Inn. As this year's convention is being held at such a wonderful location with a great price, we are encouraging everyone to feel free to invite family and friends to share in this opportunity to enjoy a great vacation in one of the very special resorts in this country.

A Professional Seminar is scheduled for Sunday October 2, 2011 from 10:30 AM to 3:30 PM, which includes a break for lunch. The seminar is a four-hour session that can be used by attendees to meet annual CPE requirements for the Association of Certified Fraud Examiners, Association of Certified Fraud Specialists and Enrolled Agents. From the Executive Director

Odds and Ends -

- Looks like we are firmly entrenched above a membership level of 1200! We had reached a high of 1223 but as dues come due we inevitably lose a few (sorry, couldn't resist). We lost 40 members this year that did not renew, about 5 fewer than last year, and with a bigger base.
- Scholarship applications its time to start working on these. There may be some tweaking of rules, but references will not be adjusted and that is one of the toughest things to get in timely. And we do expect timeliness to be a factor this year. As it stands, complete packages are due at the AFSA PO Box by May 1! So work on those references. We may expect a little more involvement by the sponsor (member) this year, such as certifying they have reviewed the package and feel it is complete.
- Retired agent badges- AFSA has nothing to do with these. We merely got the word out on behalf of HQ to our members. Last word I heard from a member who spoke to HQ in mid-February was the company, V.H. Blackinton, was processing the orders. Some of you may have paid in November or December. However, this was a one-time offer and they could not process orders as they came in as that would be cost prohibitive with a product like this. In addition, they held back sending the orders to the company a bit, figuring some people would get their orders in late, and they did. In fact, I had about a half-dozen members contact me who wanted me to see if I could delay the processing further because they did not see the notifications in the email, website or newsletter. Sorry, I could not comply with those requests because I have had dozens of people contacting me about the delay. Latest word in mid-February was the orders would be completed and sent to HQ to send out. Estimated time of completion from mid-February was 60- 90 days.

- We continue to add links to our website that may be of benefit to our members.
- Please, if you have information you'd like to share in narrative form to AFSA, send it in to me, or to our editor of the newsletter. If it comes to me, I can get it to Ross, our editor.
- If you have a contact that frequently hires people with our skills, encourage them to go to our website and post the openings. I review and approve them and then contact the poster if I see a problem. I normally attempt to email them out, or combine a few in an email.
- We are still looking for someone who takes an interest in politics, probably in the DC metro area but not necessarily so, who would volunteer to be our legislative liaison, to keep members posted on pertinent legislation via the web or newsletter, similar to what FLEOA does. Contact me if you are interested.
- Suggestions for the website and improvements or for AFSA in general? Send them to me and we'll see what we can do.
- Convention 2012- Do you want to sponsor a convention in your city next year? Does your city have many things to do, places to go etc., that you'd like to show off? Do you feel like you could present a package that could entice the Board and members to hold the convention and your city, then contact me about a proposal that you'd like to present as a sponsor/coordinator for our Convention. It is a lot of work, but it is also nice to sit back and see job you just completed and all the enjoyment it brought. Finally, below are some redacted comments from last month about the convention- still apply and worth reading.
- **Convention kickoff.** The forms are here in the newsletter, and will be on the website. Expect it will be much fun, and should be beautiful. Remember our slogan "Bring a Friend". We've had some members stating that they would go if their friends were going. We have 1201 members. We don't know who you worked with, or who your friends are. We invite and encourage all members to attend. We agree with you, it would be fun to have a close friend, member or non-member attend with you. They don't have to be members. It would be a nice way for them to get acquainted with us if they are eligible. They don't even have to stay in your room. They can get our discounted rates as long as they register with our liaison discussed in the convention article. This year we are making an EARLY concerted effort to encourage you to invite and persuade that friend or two to attend, whether a member or not. Our tours are optional and our dinners are optional, and always have been. Golf and shooting are optional. We have received packages allowing our members to get the discounted rates 3 days prior to and 3 days after our convention, so that you can do even more events/golf/tours/relaxing than just during the convention. Speaking of the convention, there has been some discussion of the timing around religious holidays. We attempt to have two Board meeting per year, a teleconference in March and a meeting and Business meeting at the convention, along with elections, about 6 months later. To some extent, this affects our timing. We did check a calendar last September, and we specifically did not have anything planned during THE listed religious day on the calendar, which begins on Sundown on 9/28 through to sundown September 29th. I understand some people observe more than the main day. We can't please everyone. We hope you can hit the road for awhile after sundown on Friday if you are one of these, or very early Saturday. Official activities don't start until around noon on Saturday. Last year, we had the convention starting the

day after the noted religious days on the calendar. We recognize that everyone has different priorities, and hope that all will be able to make it for a couple days. Remember, discounted rates apply 3 days before and 3 days after the official convention which is 9/30-10/4 (check out on the 5th).

In summary, we received some great and interesting comments and we did as much as possible to accommodate a wide group of people while realizing we can't please everyone all of the time. We selected a great site this year. If you have never attended, you know the dates, if you're working, you have the business items on a weekend so you can attend, not miss work and maybe even get a tax deduction. If you aren't working and want to kick back, this is a great opportunity. If you want more networking, I can promise you that networking always occurs when you get a bunch of people together. I can promise you that you will get more networking about consultant work there than you will sitting on your couch. I don't expect people to make every convention, but give one a try. As I said, I was very impressed with my last (and first) one. Invite a friend, pass along the information, have them check the links and stick with it. Make this a priority with you and your spouse and enjoy some down time, and if you can actually accomplish some business, so much the better. Invite your friend(s), tell war stories, learn about how others are working, or where, make some contacts with some vendors and get tips on resumes from them, visit the luxurious Grove Park Inn, see beautiful, mountainous NC in the fall while the leaves are changing, see a play, treat yourself to a good meal, pamper yourself at the spa, shoot a round of golf or take a hike, try to enjoy life a little. Realizing there is a cost involved that many cannot afford on an annual basis, then try to make a convention every other year or two. I appreciate everyone's comments and time, I hope we have changed some minds, and hope we can continue to adapt to be what you want your organization to be. Message from CI Chief Victor Song...



IRS Criminal Investigation has just launched an exciting workforce development pilot on behalf of the IRS. Known as the Accelerated Leadership Program, the ALP is designed to attract, develop, and retain high potential individuals by fast tracking them into management.

This pilot is a direct result of the recommendations of the IRS Workforce of Tomorrow initiative. Commissioner Shulman created the Workforce of Tomorrow Task Force in 2008 with a goal of making the IRS the best place to work in government and ensuring that within five years, it has the leadership and

workforce ready for the next 15 years.

The ALP is designed to take individuals who already have some leadership experience and accelerate development of their technical competencies so they are prepared to compete for front-line manager positions in far less time than the 16-20 years it now takes individuals to move into management.

The program was initially delayed a year due to budget considerations, but CI recently hired eight ALP special agents to launch the pilot. They are currently working with mentors in various posts of duty before beginning their training at the NCITA in April. The ALP will focus on accelerated development from GL-1811-7/9 Special Agent entry level technical positions to IR-1811-04 management level within three to five years. Each ALP special agent will participate in a formal leadership development plan that will require him or her to complete mandatory activities within an expedited timeframe including: On-the-Job-Instructor (OJI) directed technical assignments, the full spectrum of law enforcement activities, required reading, elearning, and ALP seminars. The development plans can be personalized with "optional" task assignments in addition to "mandatory" tasks at each grade level. When they have finished their training at the NCITA, the ALP special agents will be assigned to posts of duty in either New York, NY or Los Angeles, CA.

The ALP will not replace the traditional IRS leadership path through the Frontline Leadership Readiness Program (FLRP); the two programs will continue side by side. However, if successful, the ALP pilot will validate a more rapid approach to cultivating the next generation of IRS leadership.

In addition, CI will also soon launch its own Accelerated Senior Leadership Program (ASLP). The ASLP will accelerate the development and advancement of GS-13 special agents and current leaders to senior and executive levels with an emphasis on leadership competencies. The ASLP will involve a multi-year commitment to a fast-paced, high workload program with a customized career development plan. The goal is to enhance the CI "leadership pipeline" so we have highly qualified individuals prepared to move into leadership positions. With these two initiatives, CI is taking the lead in finding and developing our leaders of tomorrow.

AFSA COLLEGE SCHOLARSHIP

Response from Executive Director: This has been brought up before. First, we are the Association of <u>Former Special Agents</u>, so our primary focus is former agents, and consequently, this is primarily concentrated on retired members from IRS-CI who constitute about 85% of our membership, and couple percent (included in the 15% are agents who have not retired from Government service, but have left to work at another agency.

We are unlike FLEOA which does offer reduced rates to retired members, because their focus is active Law Enforcement Officers. I may also add, that their membership is much greater than ours going across all agencies, and their fee for retired members is still \$40 I believe, and much more for active agents. An *a'la carte* menu, would be cost prohibitive, and there is no way of verifying information.

Age itself is not a precursor for hardship, some of our wealthiest members are also some of our oldest. As far as why a person opts to not attend a convention (which is basically paid by the attendee (less than \$1.75/member was used to cover costs at the convention last year)), or chooses to not utilize on line services, well, we have fixed costs, and diversified interests of our members which include social gatherings, retirement news, sporting events, shooting events, job listings, networking, cpe, etc. We hope to provide as much to members as we can for our cost, and the cost to the member.

While I sympathize with your case, and recognize there may be others out there in similar situations, I hope you can understand why we cannot make this accommodation, along with my apology.
