Hello again, CI family. I'm happy to send a quick update to our retired agents association---

As Fall descends upon us and the leaves begin to turn, we put a bow on the year in which we celebrated our 100<sup>th</sup> birthday. We cut cake, told stories of our past and reflected on the legacy or our great agency. It was great to reconnect with agents and professional staff that I had not seen in years. # **2019 AFSA Convention Recap**



The 2019 AFSA-IRS Convention was held from September 18-21, 2019 in Washington DC. Attendees participated in a variety of tours and events, but the highlight was on Friday, September 20<sup>th</sup> at which time the actual "convention" activities took place in the U.S. Department of the Treasury Building at 1500 Pennsylvania Avenue, N.W. Convention Coordinator Dan Pieschel, along with Don Fort, Chief, Criminal Investigation (CI), were able to reserve the famous Cash Room, inside the building, for our special 100<sup>th</sup> year anniversary event. This beautiful room, with bronze gaslight chandeliers, functioned principally as a "banker's bank" upon opening in 1869. The bank supplied area commercial banks with coins and currency from Treasury vaults and handled the government accounts of the District of Columbia. Services were also offered to the public, including cashing of government checks, exchanging new money for old, redeeming silver and gold certificates, and selling U.S. Treasury bonds. Up until the early 1900s, gold, silver, and paper currency were delivered to the Treasury Building in horse-drawn vans and unloaded at the sidewalk entrance on Fifteenth Street. After many years of use and visible wear and tear, the room closed in 1976. However, the historical significance remained. Eventually funding was acquired, and the Cash Room was slowly restored to its former splendor and elegance by using photographs, some of which were taken around 1870.

On September 20, 2019, retired agents and friends spent the day in this Cash Room, and actually walked into the vault that was used to store currency many years ago. After our opening ceremonies, the agenda started with an address from Chief Fort and the Deputy Chief, James Lee, who provided their "State of the

Organization", including challenges they are facing with resource allocation and case selection. A film featuring media coverage from the past year was impressive, showing IRS-CI agents' involvement in many high-profile investigations. The AFSA-IRS business meeting was next, followed by a continuation of CI-related issues from the Director of Communication and Education, Justin Cole. Lastly, retired special agent and money laundering expert witness, Don Semesky, showed some images and offered accolades to CI agents in regard to many investigations over the years. He also talked about his involvement, since retirement, in several investigations for which he offered guidance and testimony. Throughout Don's presentation, he spoke proudly of the IRS special agent possessing a unique skill set that enabled the government to bring down many "Al Capones" over the years. His case highlights and enthusiasm were a fitting way to end the 100<sup>th</sup> year celebration in the Cash Room on Convention Day 2019. Following the events in the Cash Room, the day continued with a nice mix-and-mingle that included refreshments and hors d'oeuvres at Mackey's Public House. A loop containing photographs from all of our past convention was shown on the screens throughout our party room.

Every AFSA-IRS convention is memorable, given the venues that are chosen and the activities that are planned for our agents and retirees. Washington DC was no different and a good time was had by all. The first day included a guided tour and visit to the National Law Enforcement (LE) Memorial, which opened in 2018 and provides an overview of LE in many U.S cities nationwide. The interactive museum allows the public to participate in crime solving, surveillance, shooting exercises, and other activities endured by the LE officer. The museum also offers a history of law enforcement, including investigative techniques, uniforms, communication tools, and firearms. The museum tour was followed by the President's Meet-and-Greet/pizza party back at the lovely Washington Marriott Wardman Park Hotel.

On the second day, September 19, 2019, most attendees participated in a tour of the U.S. Capitol and/or the Pentagon, which was all pre-arranged and partially narrated. Others took to the links by hooking-up with the annual CI golf tournament, where over fifty agents, current and retired, met and competed at the beautiful Country Club at Woodmore in Mitchellville, Maryland. Still others visited sites on their own, as the hotel was only one block from a Metro station and was also along the free Circulator line.

The final convention day featured a bus tour, guided by a Washington DC native who provided the history of our nation's capital, and descriptions of major sites throughout the area. Key stops allowed attendees to walk to the Vietnam Veterans Memorial, Korean War Veterans Memorial, and Lincoln Memorial, and then later at the Martin Luther King, World War II, and FDR Memorials.

All of these events provided a vacation in the District of Columbia, coupled with continuous engagement with other members and guests throughout the tours, dinners, and the nightly hospitality suite. The final banquet, on Saturday September 21<sup>st</sup>, included delicious food selections, as well as a guest speaker. Author Robert Zorn gave a passionate speech surrounding a book he wrote about the 1932 Lindbergh kidnapping. His personal connection to the crime, through his father many years ago, added an unexpected element. His dad may have, unknowingly, actually engaged with a co-conspirator prior to the abduction. This brought the tragic violation of the Lindbergh family closer to home for Zorn. He credited the T-Men (now IRS-CI) for helping solve this notorious crime many years ago.

This recap of the 2019 events provides members with a glimpse of the planning and implementation of the annual AFSA-IRS convention. We encourage members to consider an AFSA-related "vacation" in the future. They are thoughtfully planned with the agenda usually circulating by March. Hope to see you next year!



























# RETIRED SPECIAL AGENT ELLIS T. POPE CELEBRATES HIS 102<sup>nd</sup> BIRTHDAY



In September, 2019, retired Special Agent Ellis T. Pope of Neptune Beach, Florida celebrated his 102nd birthday. Ellis was born in Chattanooga, Tennessee and served in the U.S. Navy during World War II from February 10, 1942 until February 6, 1946. Upon leaving the Navy he accepted a job as a Deputy Collector with IRS (Revenue Officer). In 1951, several Deputy Collectors were reassigned to the then Intelligence Division to assist with investigations and ultimately in 1951 many were converted to Special Agents. Ellis worked his way up to a Grade 13 Special Agent before retiring after spending his entire career in Jacksonville, Florida, which at that time was the District headquarters for all of Florida.

Back then there usually was only one grade 13 per group. Ellis worked on a variety of cases in his career and some of the more memorable investigations were when Intelligence enforced the wagering laws and the Cuban Lottery was a big thing in Florida. Ellis was assigned as the spotter when aircraft were utilized to follow the suspects from the pickup locations (sales) to the checkup locations (bank) where the key players would be located. There were some anxious moments during the surveillance because Jacksonville was home to three naval air bases and often the surveillance would take them close to "no fly" zones, especially when night time surveillance took place. It wasn't unusual to see Navy fighters close to their aircraft. Ellis was also somewhat of a trickster. One time he was on the 7th floor where all of the Chief's and District Director had their offices. He saw a secretary from our Chief's office coming down the hall so he hid to the side of the fire door that had a small window and held the door shut. The person on the other side kept trying to open the door. Ellis finally looked through the window to surprise the secretary. Unfortunately, the secretary had turned into another office and the person he was stopping from opening the door was the District Director!

After Ellis retired he consulted with some prior U.S. Prosecutors who had opened well known law firms. Ellis and his wife, Lib, were always very active in their church and retirement allowed him more time to be involved with the church and with the Exchange Club in Jacksonville Beach. Ellis has four daughters who grew up in Neptune Beach. He tries to walk a couple of miles every day. He had heart bypass surgery at age 95, the oldest patient his surgeon ever operated on, but the surgeon said Ellis was in such good health otherwise, he had to perform the surgery. Obviously the surgeon was correct.

AFSA-IRS Treasurer George Meyer had the pleasure of working with Ellis for nine years and volunteered to plan Ellis's retirement party. George tries to have lunch with Ellis once a month. He said that Ellis is the nicest person he has ever known.

### AFSA COLLEGE SCHOLARSHIP

#### AFSA Scholarship Program - Awardees and Some Concerns

AFSA is happy and proud to announce the awardees for the AFSA Memorial Scholarship (formerly known as the Frank Smith Scholarship). A reminder this scholarship is awarded to qualified students with a GPA of 3.00 or above who are seniors in high school or currently enrolled as fulltime in college with any major whose applications are reviewed and ranked by the scholarship committee. The committee submits its recommendations to the Board for awarding of scholarships. The full qualification standards are on our website.

In Addition, we have another scholarship, the James F. Howe, Sr. Memorial Award. This scholarship is awarded qualified individuals (see website for qualification), but must be at least a Freshman in college, attending full time and be in a major that can be considered a law enforcement career. We have an amazing benefactor for this fund, Mr. William R. Schroeder, President and founder of Madison Associates who allows us to administer the awards and fund. This year, we did not have one candidate for this \$3000 scholarship!

These could be kids entering law enforcement at the state and local levels, or other Federal agencies. It could be your relatives considering careers as forensic accountants within law enforcement, analysts, computer experts and seized computer recovery experts, prosecutors at state, local and Federal levels, crime scene investigators.

Have you made your relatives, especially not in your immediate family, aware of this scholarship and encouraged them to apply. Are you showing interest in them to reduce their student debt? Let's look at ourselves and start pushing these scholarship applications to our eligible relatives in late winter to give them time to apply, and to continue the fine tradition in law enforcement that you, as members displayed, and want to be displayed at all levels of government in the future.

#### HISTORICAL CORNER – BY AL SELBY

The purpose of AFSA as stated in the amended By-Laws is as follows: "The Association's purpose is to provide for continuing association and communication among former special agents of the Internal Revenue Service; to promote fraternal relationships among agents via chapters established throughout the United States and through meetings conducted at chapter and national levels; to administer scholarship programs; to provide opportunities for Continuing Professional Education (CPE); and to disseminate information relating to job opportunities and issues affecting former and current special agents of the internal Revenue Service."

All of these purposes and goals are important; but the one that has meant the most to me personally is the promotion of fraternal relationships; especially through attendance at the National Meetings/Conventions. The AFSA By-Laws require an annual meeting and we have had an annual meeting every year since 1990 (30 years). Elsewhere in this newsletter you will find a list of the 30 places we have chosen to have our required annual meeting. Las Vegas leads the list with 5 visits; San Antonio has hosted 3 times; Myrtle Beach has hosted our convention twice; and Washington has hosted twice (DC suburbs 3 places). #### <u>HISTORIAN'S CORNER – BY AL SELBY</u>

The AFSA By-Laws, adopted in 1989 – 1990 and rarely amended significantly, require that the Board of Directors meet at least twice a year, and at least one of these meeting must take place in conjunction with the annual general meeting.

ARTICLE IV, Section 5 of the AFSA By-Laws states, "Regular meetings of the Board of Directors shall be held at least twice each year, at such places and on such dates as are fixed by the President. One of the meetings shall take place in conjunction with the annual general meeting. Special meetings may be called by the President or at the request of four members of the Board of Directors. Notice of meetings shall specify the time and place and contain an agenda for the business of the meeting, to the extent practicable." .

. .

The required annual general meeting has been called the Annual Conference by some and Annual Convention or National Convention by others. It began as a rather small gathering of dedicated members, mostly in the DC area. There were 35 members that attended that first general meeting (and some quests) and the major items on the agenda were to, 1) amend and approve the By-Laws prepared by the original officers and directors, and 2) to elect new officers and directors going forward. Membership at the time of the first general meeting was 450.

The first National Meeting was held on August 31 – September 1, 1990, at the new Marriott Hotel in Falls Church, Virginia. The hotel rate was \$65.00 + tax (low for the time and place, including free parking) and I was unable to find any registration fee. (The total convention registration fees per the Treasurer's Report were \$675.00). The only side tour I have found was a spouses' tour and luncheon at the White House on Friday morning. The plans and arrangements were made by Frank Smith and Ken Wilson; and the President was Tom Clancy. The Friday meeting was primarily to discuss changes to the By-Laws and organizational changes, and the Saturday meeting was for adopting changes to the By-Laws and election of officers. There was a hospitality room, continental breakfast on Saturday and Sunday mornings, dinner was on your own Friday night, and the banquet and installation of officers was Saturday night. The guest speaker was Michael J. Murphy, Senior Deputy Commissioner of IRS.
