- 1. Two letters of personal reference from individuals (no former teachers) who can attest to your character.**
- 2. Two letters of recommendation from instructors or professors familiar with your scholastic endeavors on official letterhead stationery.**

**Writers of the letters should include their printed name, address, phone number and email address on the letter.**
